

**12:10:02:25. Lifetime transportation permit for horses.** A lifetime transportation permit for a horse requires an ownership inspection of the horse by an authorized inspector of the Brand Board. Only one horse is covered by each lifetime transportation permit.

The permit must contain a description of the horse denoting breed, color, sex, approximate weight, and any marks or brands, and the name and address of the owner.

The person transporting the horse must have the permit in possession.

The fee for a lifetime transportation permit is ~~\$20~~ \$40.

The permit provides proof of ownership of the horse and is valid until the horse changes ownership, at which time the previous owner shall surrender the permit to the Brand Board or its authorized agent.

**12:10:02:34. Application for permission to use out-of-state brand.** A person may apply to the board on a form provided by the board for permission to use the person's out-of-state brand.

**12:10:02:36. Requirements for branding yearling stocker cattle with out-of-state brand.** Yearling stocker cattle imported or purchased for feeding purposes within the ownership inspection area may be branded with an out-of-state brand authorized by the board pursuant to § 12:10:02:34 if the following conditions are met:

- (1) An ownership inspection is made at branding time;
- (2) The owner provides the inspector with proof of ownership of the cattle;
- (3) The cattle are branded with the owner's registered brand; and
- (4) The brand is not a duplicate of or in conflict with a previously registered brand.

**12:10:02:35. Requirements for branding calves with out-of-state brand.**

Calves born to cows imported for grazing purposes within the ownership inspection area may be branded with an out-of-state brand authorized by the board pursuant to §12:10:02:34 if the following conditions are met:

- (1) The cows and calves are inspected for ownership at branding time;
- (2) The calves are branded with the owner's registered brand;
- (3) The calves are less than three months old; and
- (4) The brand is not a duplicate of or in conflict with a previously registered brand.
